### FY23 Water Service Replacement

This contract will be a work order based contract to provide construction services to Charlotte Water for the relocation or renewal of water services (3/4-inch and 1-inch), abandonment of small diameter water mains (12-inch and under), and installation of new water mains. The contract will consist of an undetermined number of individual water services relocations and other work areas throughout Mecklenburg County that will be assigned by the Engineer.

- Workers Compensation-For lost wages and medical expenses of injured workers

## Bonding Requirements

The City plans to require the following bond(s) for this solicitation:

- Bid Bond-City required Bond to ensure that vendors do not retract bids from the time they submit a bid until the contract has been executed.
- Payment Bond-City required Bond to ensure that subcontractors and/or suppliers are paid for any work performed.
- Performance Bond-City required Bond to ensure satisfactory completion of a project by the vendor.
